- c. The board discussed authorizing Sean Foran of Hueber-Breuer to authorize the prime contractors to proceed with additional work at his discretion to maintain the project schedule and work flow up to a value of \$10,000. Hueber Breuer will review all costs at monthly board meetings.

- d. Budget Workshop date(s) will be finalized at the August 6th mtg.
- e. The commissioners discussed moving the office trailer to the new property to save on costs of getting an additional construction trailer. Further information is needed.
