The Charlton Fire District located at 677 Charlton Road, Charlton, NY 12019, is accepting bid proposals to perform lawn mowing, landscape bed maintenance. Scope of work to include:

Lawn Mowing

- Mowing of Grass areas (Sod) to be preformed weekly during the Mowing Season.
- Sidewalk Edging as needed
- Weed Whacking areas not Mowed. To include, Ditch area by Road 4' down the embankment, Propane Tank and Dumpster area, and around all Planting Beds.
- Blowing and Clean up and removal of Grass (Sod) Clippings and any other Debris from Sidewalks, Mulch Beds, and Pavement Areas.

Removing all Debris from Charlton Fire Department property and disposing at appropriate disposal site.

Landscape Maintenance

- Edging of all Landscape Beds
- Pruning of all Landscape Plants, Trees, and Bushes
- Weeding in Landscape Beds and around all Building as needed or requested
- Removal of Debris from Charlton Fire Department property and disposed of at appropriate disposal site.

Spring Cleanup

- Removal of Debris that has come down throughout the Winter months. To include, Sticks, Branches, Fallen Trees, Leaves, and other debris. To be completed on Mown areas and in Planting Bed areas located on the property of the Charlton Fire Department.
- Thatch all Mowed (Sod) areas of the Charlton Fire Department, Loose Thatch to be raked out, then to be Overseeded with an Tripple Rye Grass Blend Seed mix.
- Application of New Mulch in Planting Bed Areas to a thickness of 2.5". The Mulch shall consist of Natural Wood Fibers and be Black in Color.
- This work shall be completed before the first mowing
- Removal of Debris from Charton Fire Department property and disposed at appropriate disposal site

Fall Cleanup

- Removal of Debris that has come down during the fall months. To include, Sticks, Branches, Fallen Trees, Leaves, and other debris. To be completed on Mown areas and in Planting Bed areas located on the property of the Charlton Fire Department.
- Removal of Debris from Charlton Fire Department property and disposed at appropriate disposal site
- This work shall be completed no later than December 16th , or before first snow fall
- Payments will be made monthly

The Bidder shall provide all labor, equipment, and materials necessary to complete the above listed scope of work. Proof of Liability Insurance required, along with any Prevailing Wage requirements that may apply per State and Municipal bidding laws.

Failure to state that Prevailing Wage requirements are meet in the Bid will result in Disqualifying Bid.

Failure to provide Proof of Insurance at time of Bid will result in Disqualifying Bid.

Failure to submit the Bid in the Time Requested will result in Disqualification of Bid.
